



Resolution 17—01
of the
San Mateo County Harbor District
to

**SUPPORT THE ALLIANCE OF COMMUNITIES FOR
SUSTAINABLE FISHERIES**

Whereas, the Alliance of Communities for Sustainable Fisheries was formed, consisting primarily of representatives of the commercial fishing industry, but also including port and harbor representatives and businesses related to the commercial fishing and charter boat industry from all harbors between Morro Bay to Pillar Point as identified in Exhibit I attached and incorporated by reference in this resolution and has established an office in Carmel Valley, California, and,

Whereas, the Alliance expects the Monterey Bay National Marine Sanctuary to keep the clear promise that was made to the fishing community during the designation period for the Monterey Bay Sanctuary, that the Sanctuary would not become involved in fishery issues and,

Whereas, the Alliance perceives that there is much cooperative work to be done in guaranteeing that our central California coast fisheries are sustainable in the long run and,

Whereas, the Alliance believes fisheries management should continue to be the responsibility of the California Department of Fish and Game and the Pacific Fisheries Management Council and,

Whereas, the Alliance has announced its intention to formally study several issues critical to fishing and,

Whereas, by inviting the public and the Monterey Bay Sanctuary Advisory Council to participate in the Alliance's study process, the Sanctuary and the public can have meaningful input into resolving important fishing issues without the Sanctuary breaking its promise to the fishing community.

Therefore, be it resolved, that the San Mateo County Harbor District supports the goals of the Alliance of Communities for Sustainable Fisheries, as expressed in the Alliance's February 2, 2001 letter.


