



The Half Moon Bay Seafood Marketing Association is writing in support of the proposed San Mateo County Harbor District Resolution No. 21-05 to ***“Support the State Water Resources Control Board’s Update of the Bay Delta Water Quality Control Plan”***.

Salmon was a top earnings species in Pillar Point Harbor and represented over \$38 million in landings the 10 years before 2008 when the fishery experienced regulatory closures. From 2010 to 2019 total landings in Pillar Point Harbor were less than \$15 million. This is a significant economic loss to our commercial fishing fleet, and the shoreside businesses that support them and to our port community. Salmon has been an important part of our local commercial fishing heritage and a key economic driver for more than 100 years.

If the continued loss of salmon seasons isn’t turned around, we will see more losses of commercial fishing businesses in our port and others. This is devastating to the commercial fishing fleet and the many local families and businesses that the fleet supports. Commercial fishing is variable and challenging by nature, these are things that the commercial fishing fleet understands and accepts. However, it is difficult to accept such losses of fishing opportunities that could be avoided if it wasn’t for lawsuits and politics.


Fishermen are supportive of the Bay Delta plan moving forward and appreciative that the San Mateo County Harbor District recognizes the importance of this issue.
